PRESIDENT'S REPORT

President Richardson opened the meeting with a welcome to all. He outlined what he hoped to accomplish and his desire to do so promptly.

1- He asked for the reading of the 2011 Board Meeting minutes. A motion by Bob Cooper, that the minutes, as published in the October 2011 Newsletter, be accepted. This was second and passed with thanks by the Secretary.

2- Treasurer "Bud" Lawson reported our bank account balance was \$21,208.28. Due to many problems, he was unable to give a detailed report.

3-Bob Richardson reported on the physical and financial status of the 2012 Dayton, OH Reunion. Bob deserved a big "**WELL DONE**" for his coordination and directing of the Armed Forces Reunions, Inc.

4-Susan Clark Lanson reported all activities of the 2011 Reunion were closed. She returned \$4172.00 of the \$10,000 start-up funds to the Treasurer

5-Scott Miller gave a brief report on placing 43rd Bomb Group data in the George Mason University Archives. Steve was thanked for the rapid handling of data and having it available for the 2012 Memorabilia Room.

6-Dan Knickrehm reported his activities as the 43rd Airlift Group Historian. Dan also reported he was traveling in his truck and would be able to take any Memorabilia and data to the JAY ZEAMER HEADQUARTERS BUILDING on Pope Air Force Base for archiving and proper display. An e-mail is an attachment, in which Dan tells of the plan for 43rd Bomb Group history.

NEW BUSINESS

1-Status of the Board Members: The Secretary informed the 63rd, -64th and 65th Squadrons that 2012 Directors terms were expiring and sadly the 403rd Squadron had lost both of their Directors. President Richardson directed the Squadron to elect new Directors in the Squadron Meeting and to present them during Thursday's General Business Meeting.

2-Since there is no longer a standing Nominating Committee, New Officers and Board Members to be presented at the General Business Meeting was obtained by appointment or voluntary participation. The president will present these candidates at the General Meeting for consideration.

3-President Richardson asked if the Association should be shut down? The reply was 10 **NO** to 2 **YES**.

4-In view of the declining Membership, a discussion pertaining to **who can vote, be officers and directors** as defined by the **BY LAWS OF 43rd BOMB GROUP ASSOCIATION, INC.**, was conducted and resulted in this resolution--"**Resolved that the Child of a current or**

past Member may become a Member with the right to vote and hold office effective immediately.” An amendment from the floor was made to change the word **Child** to **Descendant**. The amendment and resolution was approved by the Board–10 Yes and 2 No. 5-Robert Cooper, being a good Texan, volunteered to be the Custodian of our Texas incorporation **CERTIFICATE 43RD BOMB GROUP ASSOCIATION, INC.** The Secretary was instructed to send Robert the requirements for maintaining a current certificate. 6-The Board instructed the Secretary to delete all PD-07 delinquent dues Members from the Mailing List. 75 delinquent members have been removed from the Mailing List!

OLD BUSINESS

- 1- The Secretary and Treasurer reported handling of newsletter and banking, in Snyder, TX, appears to be improved. The Elain Pierce work load has been reduced as we clean up the mailing list and transfer the newsletter to our web site.

It isn't quite that simple but we are finally down to the last few weeks of the 43rd project. After a final scheduling meeting with my chief of staff, Jeff Moskowitz, we've set the final publication dates for the 43rd project and the other unit histories that are virtually completed. I've attached a copy of the memo to my employees that sums it up. When you get back from the reunion, we need to talk on the phone because we need to do planning for shipping books to current addresses of all of those who have previously pre-paid for books, and arrange how to handle the orders from people who are deceased or have no traceable next of kin. I want to have the shipping boxes all pre-labeled and ready to go when the books actually arrive in here in Colorado, so that there is no further delay in their receipt by those who have ordered them. As you can see from the attached memo, we've had to break both the 43rd and the 38th Projects into two separate volumes each due to excessive length. Everyone who has pre-ordered the books will therefore get two books for their purchase price, not a single volume. This is a very expensive way to go for me, but was necessary in order to maintain the overall quality of the project.

With the 3rd and 38th BG projects, I've currently got veterans from both units acting as "technical editors," whose task is to review the text and make sure that any obvious or stupid mistakes haven't crept into the manuscripts. I'm confident in the quality of our work, but I've always done this with every book that I've published and I've always been glad that I did. We don't have much time left, and we are extremely busy here with the final layouts, but we can still make minor changes and corrections for a short while. So, I'd like your recommendations of people from the 43rd who might have the time and interest in reviewing sections of the text that relate to the period when they were with the unit. We are just now going through our third and final edit at the same time that we are splitting the project into two parts, so as the chapters come out the other end of that process I'd like to see if we can still do this. Jeff is overseeing the overall project management and I'm handling the final editing and checking process. Jeff is the person working with the technical editing side of things, and he would be the one who you would work with you on this. I have my hands full doing the final edit and fact checking.

I'm sorry that I didn't get this to you sooner, but I'm totally swamped every minute of the day, and it has been a complicated and challenging task to put this final production schedule together.

In 2010, I received a special invitation to celebrate the 85th Anniversary of Tauck World Discovery, hosted by the Tauck family and CEO, Dan Mahar. The invitation said, "We combed the world in search of the perfect destination for a special anniversary event - and we found it in Rome, the Eternal City." Not only had the brochure promised we would visit the "must-sees"; there would be a private night of opera, a private Italian designer's fashion show, private lectures by noted Rome "insiders", and our hotel would be the Westin Excelsior, known as the "Grand Dame" of Rome. I made my reservation that very day.

The highlight of my "Roman Holiday" was the evening we had a private viewing of the Sistine Chapel, where we could stay as long as we desired to marvel at the masterpiece created by Michaelangelo. Then we were escorted to the Courtyard of the Pineapple to enjoy champagne, appetizers and canapes, followed by an incredible five course dinner accompanied by a quartet playing Renaissance music inside the Vatican Museums in one of the most admired galleries, the magnificent Braccio Nuovo, the Pope's private dining room, usually reserved for state dinners or special state occasions and rarely available to the public.

He fell asleep and opened his eyes to see my Mom, his parents, his brothers Don and Tony, his sisters, Frances and Mary. And I know they are all up there waiting for me. When God calls for me, I *will* see Pops again. I believe that to the depths of me. But there's something else about his death that I want you to know, and it wouldn't have been possible for me to know it if I hadn't been able to attend the reunion: remember the breakfast and the Memorial this morning, on Sunday the 28th? During the latter, a man from each Squadron stood up and read the names of the men who'd gone on during the past year. Then a bugler blew Taps, and all the men stood at attention, saluting their comrades. Then you and I went down to the Memorabilia room and talked for a while 'til I was given the news that my Dad had died. Ed, I talked to my brother and we determined that my Dad died at perhaps *exactly* the time all his brothers-in-arms were standing at attention and saluting while that bugler played Taps. I cried when I saw and heard all that, thinking of the Kensmen I've already "lost" and knowing my Dad likely wouldn't be on earth for the next reunion. Now that I know more about the timing of my Dad's death, I believe his soul was just leaving his body, en route to see the Face of Christ, *at that very moment the bugler was playing his dirge*. Maybe Dad was even in that room with us. It seems that those notes were not only for his fellow warriors, but for my Dad, too. And I got to be there.

I think there is something so perfectly and beautifully poetic that I got to be there in that room for that Memorial service at that exact time. I really have no words to express what it means to me. Like I told you, Hazel, and Susan, if I couldn't be at my Dad's bedside when he moved on, I'd have wanted to be with you Kensmen.

And there's one final thing: that morning, during the breakfast, I went around showing everyone this little baby "onesie" that has the words "Great-Grandkid of a Kensman" on it. I got it for my Dad's soon-to-be-born great-grandson, due on December 31. I think there's something beautifully poetic in *that*, too. An illustration of that great "circle of life." I'm proudly showing off this little "Kensman" baby outfit to you men and your families, an outfit to be worn by my Dad's great-grandson who hasn't even been born yet -- and moments later, my Dad got called home, with all his Kensmen brothers gathered together, mourning their dead. That little great-grandson of his will grow up knowing all about his Grandpa and what he and his fellow Kensmen did during the War. I will make sure of it. And maybe the 43rd Bomb Group Association will be filling out its membership ranks by that little baby and his brothers, sisters, and cousins twenty years from now. They will if I have anything to say about it anyway!

I dunno, Ed. The Reunion has been five of the greatest days of my life. And while it seemed to end on a sad note -- well, it *did* end on a sad note -- the note was played by a master musician who knew how to make music that's not just bitter, but *bittersweet*. There's no one outside of blood family I'd rather have cried on when hearing about my Dad than you. And, aside from being with Dad himself, there's no place I'd rather have been when Dad went to Heaven than with his Kensmen brothers. And to have had a bugler playing Taps and all you Kensmen at attention and saluting while my Dad's beautiful soul went skyward -- that is magical. I've got no words... No, I *do* have words: thank you. Thanks to all you beautiful Kensmen. Thank you, thank you, thank you. I love you all.


